FINANCIAL (price) EVALUATION

The financial evaluation will be made based on the total cost of the financial evaluation (price of the offer), calculated on the basis of the cost simulation scenario provided in Application form.

Assessment under the criterion "price" will be based on the following formula for each category:

P= Pmin/Pof x 40 points

where:

Pmin - the lowest proposed price

Pof - price presented in the examined offer

P – the number of points awarded to the examined offer under the price criterion, rounded to the full number.

AWARD OF THE CONTRACT

The contract will be awarded to the most economically advantageous tender, which will be established by weighing technical quality against price on a 60/40 basis.

The final score will be calculated using the following formula:

Final score = Technical score x 60% + Financial score x 40 %

The tender obtaining the highest final score will be deemed to be the most economically advantageous tender.

*Comparison of the weight of Price and other criteria is 40%

6. Information about price:

- 6.1. The price should be specified in GEL and rounded to two decimal places. The price should be given on the basis of the cost simulation scenario provided in the Application form.
- 6.2. The price may be offered in NET (for physical persons) value, that must be clearly indicated, or GROSS, that should include all costs incurred by the Contracting Authority as part of the service provided by the Contractor (taxes, compulsory social security, health and retirement contributions), as well as the costs of accommodation in Georgia, food, insurance, local travel (unless travel is ordered separately by Contracting Authority), computer equipment, cellular communication and software (word processor / spreadsheet / power point).

6.3. Settlements between the Contracting Authority and the Contractor will be conducted in GEL depending on the Contractor's place of tax residence and in relation to the current exchange rate of the National Bank of Georgia.
