3. When selecting the most advantageous offer, the Ordering Party will be guided by the following criteria:

- Price - 50% = 50 points,
 - *The "Price" criterion will be assessed on the basis of the total gross offer price for the realization of the subject of the Tender given by the Contractor. A maximum of 60 points can be obtained by this criterion.*



The number of points in the "Price" criterion will be calculated according to the following formula: $P = P_{min} / P_{of} \times 20$ points.

where:

P_{min} - the lowest proposed price,

P_{of} - price presented in the examined offer,

P - the number of points awarded to the examined offer under the price criterion, rounded to the full number.

- Warranty period and conditions - 20% = 20 points,
 - *The "Warranty period & conditions" criterion will be assessed on the basis of the information provided by the Contractor. A maximum of 20 points can be obtained for this criterion.*
The warranty period and its conditions declared by the Contractor cannot be shorter than 24 months.
- Quality of the product – 30% = 30 points.
 - *The "Quality" criterion will be assessed on the basis of the certification attached to the subject of the Tender, that the product is genuine and official.*

4. The offer shall include the following documents:

- Invoice (with VAT and without VAT),
- Warranty document,
- Certificate of genuineness (*on each of the equipment*).
