General Information

INTERNET ACCESS FLAGSHIP: Rural Empowerment through Digital Inclusion (REDI) is an EU funded project that Solidarity Fund PL in Georgia (SFPL in GEO) began implementing on December 1st, 2023, together with our partner - the e-Governance Academy from Estonia (eGA).

By virtue of its innovative approach, this action will reduce the existing digital division and include those traditionally left behind by improving access to affordable digital infrastructure and developing digital literacy skills in rural areas of the target regions of Imereti, Guria, Racha-Lechkhumi and Kvemo Svaneti and possibly Kakheti.

Job description:

The Logistics Officer plays a crucial role in procurement, purchase and maintenance of technical and Wi-Fi equipment, Digital Rural Hub (DRH) equipment and other ICT equipment implied under the REDI project. The position shall oversee the compliance of the equipment to be purchased with the requirements/needs of the project, supervise the purchase procedures and warehouse management, assist and support installation process, as well as maintenance of the equipment in accordance with relevant technical and safety standards. The Logistics Officer plays a critical role in ensuring the successful and accurate purchase, maintenance and flow of the equipment from the warehouse to installation points. The position ultimately contributes and supports the process of designing a network of access points as well as overall achievement of project outcomes.

Working hours:

- The regular working hours consist of 40 <u>mandatory</u> hours per week.
- 75% of the regular working hours is to be performed from Monday to Friday, from 11:00 to 17:00 physically at the office or online at the computer desk (30 hours in total). 25% of the regular working hours is to be performed at time, space, and form preferred by the Employee.

 Working time includes 2 working days online from home and three working days from the office; The changes may apply upon prior notification and agreement.

Employment conditions:

The employment contract will initially be signed for the probation period of 6 months; with a prospect of prolongation for an additional 18 months if performance is satisfactory.

Tasks and responsibilities:

- In the Equipment Pre-Purchase Phase

- To oversee the entire supply chain process of procurement of technical equipment and materials necessary for setting up Digital Rural Hubs (DRH) and internet hotspots in the rural areas of Georgia.
- To conduct local market research for supply, services, and works in the field of digital equipment and connectivity technology.
- To prepare TOR for digital equipment, and connectivity technology, technical specification inputs for tenders, specifying required quantities, type, and quality of the equipment; obtaining all necessary financial documentation to support purchases.
- To liaise and negotiate with local vendors regarding proposals and information for the purchase and maintenance of equipment, materials, and services; negotiating with suppliers, managing contracts, overseeing purchasing process and ensuring timely delivery within the budget constraints.

Following Purchease of the equipment Phase

- To deploy and maintain equipment in the warehouse, with necessary safety standards and accurate warehouse policies; To create and keep sustainable inventarization, equipment maintenance and safety system.
- To organize the process of delivery and distribution of technical equipment across the targeted rural villages and provide assistance in the process of equipment deployment and installation.
- To participate in technical evaluations and post-tender preparations as well as necessary contracting procedures.
- To the extent, required by aims of the project, support technical expert in internet network planning process.
- To identify potential logistics risks related to transportation and customs clearance.
- To develop and implement risk mitigation strategies related to the technical equipment procurement, purchase, deployment, installation and Maintenace accordingly, with the support and supervision from the Project Manager.
- o To collaborate with the project team for a good understanding of procurement needs and proactively address requirements.
- To consult with the Project Manager and ensure the proper allocation of the budget dedicated for procurement activities.
- To perform other tasks as required.

Minimum eligibility qualifications:

- Bachelor's or master's degree in engineering, ICT technologies and/or related field;
- Minimum of 3 years of experience, working in Logistics, procurement, equipment maintenance or similar positions (work in telecommunication and/or ICT sector will be considered as advantage);
- A good understanding of procurement processes, regulations, and best practices. Knowledge of procurement policies, procedures, within EU will be an advantage;
- Knowledge and work experience with MS Office (Word, Excel, PPT, etc.);
- Fluency in English and Georgian (both written and spoken) is required.

- Excellent communication and interpersonal skills, with the ability to engage effectively with diverse stakeholders;
- Proven ability to work independently, prioritize tasks, and meet deadlines in a fast-paced environment.
