# Call for Service: Hotel Service and meeting facilities in Kutaisi, Georgia

Solidarity Fund PL in Georgia is looking for a qualified company to provide hotel accommodation service and meeting facility in Kutaisi.

#### Service Requested:

Hotel accommodation services and meeting facility in Kutaisi, Georgia for Solidarity Fund PL in Georgia to conduct 4 training sessions from late September to late November, as part of the project "Local Media Accelerator": be well informed.

### 1. The tasks under planned assignment are as follows:

1.1. Provision of 15 to 20-room hotel accommodation in Kutaisi for 20-25 people participating in the events planned by the Solidarity Fund PL in Georgia.

**1.2.** Provision of catering service including breakfast, lunch and meals during breaks between training.

1.3. Provision of a meeting place for training sessions planned by the Solidarity Fund PL in Georgia.

### 2. Duration of the assignment:

From September 17<sup>th</sup> ,2024 to November 25<sup>th</sup> , 2024.

### 3. Place(s) of Assignment

Kutaisi, Georgia

### 4. Minimum requirements

4.1 The hotel shall have a 3-star rating or higher according to the hotel classification standards in force in Georgia.

4.2 The hotel shall be in Kutaisi.

4.3 SFPL shall have the right to cancel bookings up from 1 week to 48 hours prior to the day of arrival without any charge.

4.4. Multi-lingual staff available, with English as a mandatory requirement;

4.5. All areas of operation shall meet a high level of quality for cleanliness, maintenance, hospitality, and delivery of services;

4.6. Once registered, guests should have 24-hour access to the hotel, facilitated by on duty staff;

4.7. Catering services available for breakfast, lunch and dinner during the training sessions;

4.8. Complimentary Wi-Fi or internet connection with a minimum internet speed of 10 Mb/s;

4.9. The hotel shall provide the service of luggage-keeping;

## 5. Selection criteria for shortlisted applicants (max. 100 points)

## FINANCIAL (price) EVALUATION

The financial evaluation will be made based on the total cost of the financial evaluation (price of the offer), calculated on the basis of the cost simulation scenario provided in the Application form.

Assessment under the criterion "price" will be based on the following formula for each category:

P= Pmin/Pof x 40 points

where:

Pmin - the lowest proposed price

Pof - price presented in the examined offer

P – the number of points awarded to the examined offer under the price criterion, rounded to the full number.

#### AWARD OF THE CONTRACT

The contract will be awarded to the most economically advantageous tender, which will be established by weighing technical quality against price on a 60/40 basis.

The final score will be calculated using the following formula: Final score = Technical score x 60% + Financial score x 40%

The tender obtaining the highest final score will be deemed to be the most economically advantageous tender.

\*Comparison of the weight of Price and other criteria is 40/60%

### 6. Information about price:

6.1. The price should be specified in GEL and rounded to two decimal places. The price should be given on the basis of the cost simulation scenario provided in the Application form.

6.2. The price may be offered in NET (for physical persons) value, that must be clearly indicated, or GROSS, that should include all costs incurred by the Contracting Authority as part of the service provided by the Contractor (taxes, compulsory social security, health and retirement

contributions), as well as the costs of accommodation in Georgia, food, insurance, local travel (unless travel is ordered separately by Contracting Authority), computer equipment, cellular communication and software (word processor / spreadsheet / power point) if any.

6.3. Settlements between the Contracting Authority and the Contractor will be conducted in GEL depending on the Contractor's place of tax residence and in relation to the current exchange rate of the National Bank of Georgia.

7. The application must contain Fiscal Statement and Application FORM (templates attached), signed and scanned in PDF format.
